#### **SUBJECT : AME LICENSE EXAMINATION – 2016 SESSIONS**

In accordance with DGCA Public Notice No. 11-690/Amnd Rule 61/ SED & ASRG / 2015 dated 13<sup>th</sup> Jan 2016, the compliance date of clause (ii) of Subrule 14 of Rule 61 of Aircraft Rules 1937 has been extended upto 30<sup>th</sup> June 2016.

In view of the extension of compliance date, it has been decided to conduct AME license examinations for the year 2016, February Session, in accordance with the Civil Aviation Requirements, Section 2 (Airworthiness), Series L, Part II, Revision 5 dated 9th November, 2012.

In view of the above, the candidates desirous to appear in AME License examination - February, 2016 session, are hereby intimated that they may forward their CA-9 (Written) application forms duly filled in and completed in all respect along with requisite fees to Central Examination Organization (CEO), O/o Director General of Civil Aviation, Government of India EastBlock-III, Level-3, R. K. Puram, New Delhi 110066, <u>latest by 2<sup>nd</sup> February, 2016 by speed post /</u> registered post only.

The applications received after the above cutoff date shall not be accepted. Incomplete applications are liable to be rejected. No communication / request in this regard shall be entertained.

# AME LICENCE EXAMINATION, FEBRUARY 2016 SESSION

## **IMPORTANT INSTRUCTIONS TO THE APPLICANTS**

The last date for submission of duly completed application forms for written AME Licence Examination, FEBRUARY 2016 session is  $2^{nd}$  February 2016.

- **a.** All Candidates (AME Trainees, Private, Defence & candidates of scheduled / non scheduled operators) should submit their applications, along with necessary supporting documents (10th, 10+2, AME course completion certificate (C of C) & experience certificates and relevant pages of log books as proof of experience claimed etc.), through speed post /registered post only. No application will be accepted by hand / courier / e-mail. Incomplete applications / applications with wrong demand drafts /applications received after the last date i.e. 2<sup>nd</sup> February 2016 will be rejected and no communication in this regard shall be entertained. Applications once rejected will not be entertained for this session.
- **b.** Request for change of centre / paper / category, will <u>not be entertained</u>, once the application is received in CEO.
- c. The fee for written examination is **Rs.500**/ PER PAPER. The draft should be drawn in favour of "**PAO**, **DGCA**, **MCA**, **New Delhi**." **payable at New Delhi and draft should be made on or after the date of publication of these instructions i.e.** <u>14-01-2016</u>.
- **d.** Quality Managers of scheduled / non scheduled Airlines A.M.O's / Chief Instructors of approved AME training institutes are advised to send only **one consolidated bank draft** as fees for their candidates along with list of candidates with paper & category mentioned against their names.
- e. Candidates are advised to mention their computer number, name and session of examination on the reverse of the Bank Draft. No combined draft shall be accepted in case of individual private candidates including defence.
- **f.** Candidates of scheduled / non scheduled operators / AMO's / approved AME training institutes should send their applications only through their Quality Managers / Chief Instructors respectively and NOT as individual or private candidates.
- **g.** The Quality Managers of scheduled / non scheduled Airlines A.M.O's / Chief Instructors of approved AME training institutes are **advised to segregate** the '**FRESH**' [*candidates appearing in any new paper(s)*] and '**REPEAT**' [*candidates appearing in any particular paper(s)* for which he has been already accepted by CEO in any previous sessions] candidates & send the applications with <u>TWO separate lists</u>.

- **h.** Instructors of AME Training Institutes, eligible for appearing in the AME Licence Examination should send their individual applications along with necessary supporting documents, duly forwarded by their Chief Instructors and Sponsoring organization column in CA -9 of their application forms should be filled as "Instructor (org name)". Instructors should send their Bank Drafts individually and not clubbed with students of their Institutes.
- i. Candidates who have passed their Paper 1 before 1992 should submit their duly attested result of Paper 1 (combined paper 1 & paper 2) /BAMEL / AME Licence copy along with the application while applying for Paper 3.
- j. Examination dates for February 2016 session will be published on DGCA web-site.
- k. The envelope containing the applications for AME Licence Examination February 2016 session should be super scribed in capital and bold letters as: "APPLICATION FOR AME LICENCE EXAMINATION FEB - 2016 SESSION"
