Examination Portal for Flight Crew License Examination for 1 of 2020 Session will remain Open from **6th January, 2020** to **13th January, 2020** for Flight Crew License Categories PPL, CPL, and ATPL for both General & Technical papers as well as ATPL Oral Examination.

All NEW Candidates who have already received their computer number and OLD candidates who have successfully registered in pariksha.dgca.gov.in, desirous to appear in this session, must apply and submit their application online, along with the requisite fee latest by **2100 hrs** of closing date of portal. **Hard copy of Examination application is not required to be sent.**

All the New candidates who had applied for the computer number to pariksha.dgca portal, the hard copy of their computer number application (pdf generated through pariksha.dgca) along with requisite documents received at Central Examination Organization, O/o Director General of Civil Aviation, East Block-III, Level-III, R. K. Puram, New Delhi -110066 (CEO) on or before **30th December 2019** and if their application is correct and complete in all respect will only be allotted with computer number and shall be considered for this session of examination.
